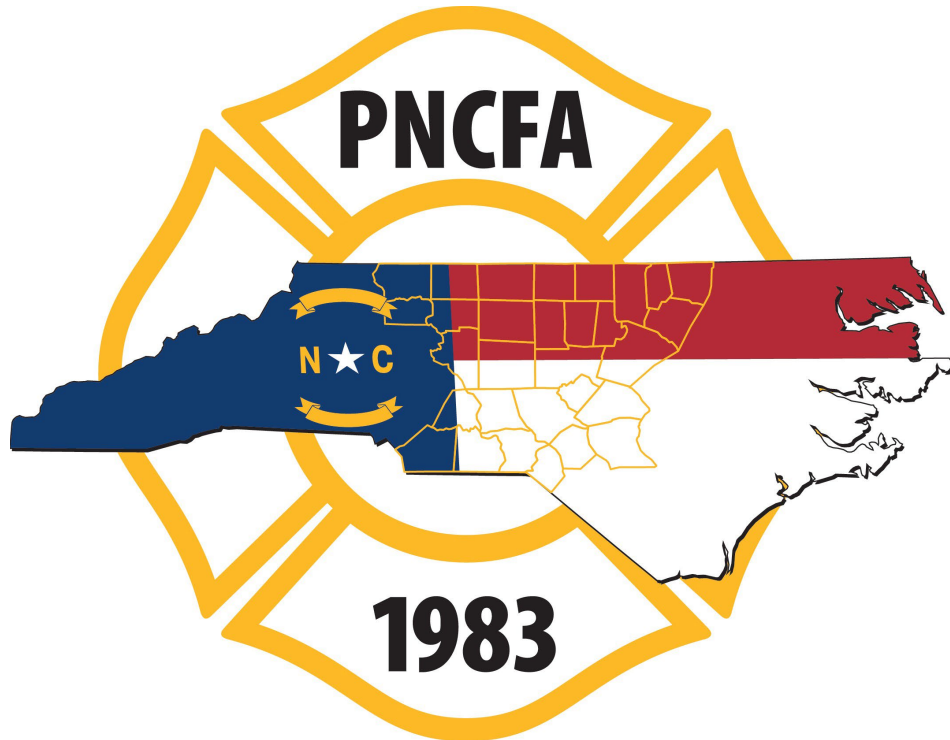

Scholarship Overview

The Piedmont North Carolina Firefighters' Association (PNCFA) will sponsor the following scholarship.

One Master's Degree scholarship valued at \$2,500 will be awarded annually to a successful applicant in the Piedmont voting district.

Scholarship applicants that are awarded a PNCFA scholarship are ineligible to apply for another PNCFA scholarship in future years.

Overview of Scholarship Rules

The PNCFA Scholarship Administration Policies direct all aspects of the PNCFA Scholarship Program.

Applicants must have obtained a Bachelor's degree prior to applying for the Master's degree scholarship.

The applicant must be a member of the PNCFA and serve in the rank of Battalion Chief or higher within their respective fire department at the time of the application submittal.

The applicants fire department must be located within the boundaries of the Piedmont voting district.

All required information must be included on the scholarship application form. If any applicant information is missing the applicant will be disqualified.

All applicants who are awarded a scholarship must attend a regionally accredited college/university that is recognized by the US Department of Education.

All applications will only be scored on the criteria submitted on the application. No other factors shall be considered and the members of the scholarship review committee will independently review all information submitted with the application.

Specifics by Scholarship Category

Career or volunteer members may apply for the Master's Degree Scholarship.

Recipients of the Master's Degree Scholarship must seek a degree in a field directly related to the fire service. These degrees include Business Administration, Public Administration, Fire Administration, Executive Fire Service Leadership, Emergency Management, Fire Engineering, Fire Protection, and Fire Investigation.

Application Process Instructions

All application packages must be mailed and postmarked by March 30th to be considered.

Application packages must contain all required documentation. Incomplete application packages will be disqualified.

An individual may only apply for one scholarship.
