## NCSFA Board-Recommended By-Law Change

The NCSFA Board's recommended amendments to the Association Bylaws was mailed and posted for review and will be voted on by the membership during the annual conference in August. The primary purpose of the recommended changes in the bylaws is to allow the Senior Regional Director position on the Board, which is the most tenured director, to automatically ascend to the position of 2nd Vice President without an election. Implementing this resulted in several necessary changes to various sections, all aimed at ensuring the Senior Director's automatic ascension to 2nd VP. These changes align with the adjustments made by the NC Association of Fire Chiefs to their bylaws in February of this year.

#### Cancer Benefit Update

As of June 15, 2025, 485 claims have been filed since the inception of the pilot program in January 2022. Of the 485 filed, 289 have been paid to the total of \$8,804,007. Of the total claims submitted, 287 were volunteers, with the remaining considered non-volunteer. Reasons for denial are the cancer was diagnosed prior to January 1<sup>st</sup>, 2022 benefit inception date, an ineligible cancer was submitted, or the member was not on the roster of the fire department.

## To be eligible for this benefit, it is imperative that you keep retirees on the roster after retirement and record a retirement date.

It is essential that Fire Chiefs keep retirees on their rosters after retirement. This is a requirement of the benefit and ensures coverage for those individuals under the Firefighter Cancer Benefit Program. Starting July 1, 2025, any retiree on the roster who has served 20 years of certified service, whether

active or inactive, will be covered by this benefit for any future cancer diagnosis, for up to ten years after retirement. There are three categories of retirees, with two relating to individuals who are no longer actively responding or certified.

## Legislative Report

This year is the long session, the first year of the two-year (2025-2026) session. The legislature has been very busy and we have been tracking several bills that have a direct or indirect affect on the fire service or our emergency services partners. #### **Engagifi**

As previously reported, Senate Bill 319 was signed into law by the Governor last year; listed below are the major changes that go into effect this year:

- \* It makes the Firefighter Cancer Benefit program permanent, removing the "pilot" status. (Effective July 1, 2025)
- \* It makes the initial profit \$37,000. The lump sum benefit is now \$74,000 instead of \$50,000 if an individual has two instances of cancer. (Effective July 1, 2025)
- \* It now includes retirees who have retired within the last 10 years. (Effective July 1, 2025). Fire Chiefs must keep retirees on the roster after retirement for eligibility.
- \* It provides permanent funding for the cancer benefit program. \* It continues to provide funding to the Volunteer Safety Workers Comp program to support and reduce premiums; (Effective July 1, 2025). \* It increases the Fire and Rescue Workers Pension Benefits from \$170 to \$175 per month and raises the premium an additional \$5 per month in order to keep the fund sound. (Effective January 1, 2025)

#### Did You Know......

Being a volunteer firefighter in North Carolina qualifies you for a significant discount on your Lifetime Resident Hunting & Fishing License. Simply go to our website and fill out the application for approval. Any volunteer who is currently on a roster and has been for the last 5 consecutive years is eligible.

## NCEMA Regional Board Meeting Update July 2025

## **Bylaws Change**

In March of this year at our spring conference, the NCEMA membership approved a revision to our bylaws. The most significant change was to allow additional members to join the association and hold officer positions. Historically the association and especially the offers were made up solely of County Emergency Managers. As Emergency Management expands, it was only appropriate to expand our membership opportunities. There are now membership categories for active members, corporate members and student members. Anyone actively participating in EM functions is eligible for active membership and allowed to vote and hold office.

#### Conference

We are currently planning our 2025 Fall Conference. It will be held October 28-30, 2025, in Eastern North Carolina. The exact location will be announced in the next few days and registration will be opened on our website soon.

## Legislation

The NCEMA leadership along with the Legislative Committee have continued to watch legislative actions in both Raleigh and Washington this spring.

In Raleigh, we have worked to ensure the autonomy of North Carolina Emergency Management and seem to have been successful. We have also worked to convince lawmakers of the need to eliminate the reliance on federal grant funding to support the Emergency Management Division's workforce and operating budget which in turn affects local budgets. We believe this is especially critical as we navigate unprecedented uncertainty about the future of FEMA.

In DC, we are working to remind our federal lawmakers that every disaster begins and ends locally. We acknowledge that the process that delivers Federal support needs reform, but while reform is needed, a federal framework must be maintained. We continue to stress the point that federal help support local actions, it does not replace them, and we need a federally supported, state managed, locally executed emergency management system.

## NVFC Regional Board Meeting Update July 2025

**DripDrop Donation** – For the sixth year, the NVFC and DripDrop have partnered to donate 200,000 sticks of electrolyte drink mix to volunteer fire departments. There is a two-week application period taking place from July 8-22. Volunteer fire departments that meet the eligibility requirements, including having at least one NVFC member, can apply for the chance to receive two cases (200 sticks) of DripDrop to help keep responders hydrated during wildfires, summer heat, long incidents, and more. We'll send out information to share with your audience on July 8.

**Firefighter Strong** – The 2025 issue of *Firefighter Strong* is now available. **Recruitment Resources** – As you probably already know, the NVFC offers free fire department recruitment resources through our Make Me A Firefighter campaign. Departments can customize recruitment materials, post their volunteer opportunities, access ready-to-use PSAs and graphics, and find training and other tools to boost their volunteer numbers. Below is a step by step information on how it works.

Many local volunteer and combination fire and EMS departments struggle to keep up with staffing demands. Recruiting and retaining volunteers are two of the biggest challenges facing many departments. With limited resources and personnel, it is difficult to create the kind of recruitment campaign that will produce the desired results.

That's where the National Volunteer Fire Council's (NVFC) Make Me A Firefighter campaign comes in. Funded thanks to a SAFER grant from FEMA, the NVFC has done the legwork of creating the materials

and resources for a full-scale recruitment campaign. Departments can simply register for the campaign (it's free!) and begin utilizing the existing content.

To make the most of the campaign and what it has to offer, follow these five simple steps.

## Step 1: Sign Up

Register for the campaign for free to get started. Simply go to <a href="www.MakeMeAFirefighter.org">www.MakeMeAFirefighter.org</a> and enter as a department. From there, click on the Sign Up button and complete the form.

#### **Step 2: Post Your Volunteer Opportunities**

Once you've registered, click on the Post a Volunteer Opportunity option to create a listing for your current volunteer needs. It is recommended to create a separate listing for each of your available opportunities, such as Firefighter, EMS Provider, Public Education, and Support Member. That way prospective recruits know about all of the options available and can select the one they are interested in.

Remember to include in the description what the roles of the position are, training that is provided, prerequisites that are needed, benefits of volunteering with your department, and any other vital information prospective volunteers should know.

Once your opportunities are posted, prospective volunteers visiting the MakeMeAFirefighter.org web site will be able to search by zip code to find your opportunity and submit an interest form through your opportunity page.

## **Step 3: Customize Recruitment Materials**

Creating recruitment materials has never been easier. Use the materials generator to find the types of materials you want to create, select the messaging and imagery from the options, and then add your department's logo and contact information. Short on time? You can also select from a range of social media posts and video PSAs that are ready to use as-is.

**Important Note:** The materials all call back to MakeMeAFirefighter.org, which is why it is important your department creates opportunity listings for the database so that prospective volunteers can find you.

## **Step 4: Utilize Training and Resources**

You will find a variety of additional resources and training available on the site that will further assist in recruiting and retaining volunteers, such as videos, guides, event planning tips, family engagement resources, and a new recruit training track to acclimate the new volunteers that you get.

#### Step 5: Follow Up

All your outreach efforts are useless if you don't follow up with your volunteer prospects. Make sure to regularly check for new interest forms that come in, and follow up with each one in a timely manner.

Your department does a lot for your community, but success is dependent on the people who volunteer their time to fulfill this mission. The Make Me A Firefighter campaign is designed to make it as easy as

possible to market your department and connect with the community so you can get more volunteers – and keep those you have.
