## **Treasurer's Report**

The Treasurer's report was presented for the period of October – December 2014. Motion to accept made by Len Needham and seconded by Tommy Cole. Passes unanimously.

## **Agency Reports**

1. NCSFA – Ed Brinson reported for the NCSFA. He introduced NCSFA board members that were presented. Several different legislature bills are being worked on at this time. One is the definition of a firefighter. A bill to authorize utility vehicles on roadways, arson charges for firefighters who commit arson. On the Federal level, a law that officially exempts volunteer fire departments from Obama Care. Mid-Winter conference will be held next week. A summit with Board members from all of the Associations will be meeting on Tuesday. Reminders will be going out for dues that have not been paid. Ed updated several programs that are on-going. Scholarship program is open and now accepting applications. Dates to remember – May 6 is NC Legislature Day. Reception for legislatures will be held on May 5. SAFRE Conference plans are being worked on at this time. Conference is in August.

- 2. NCAFC Steve Neal reported. Mid-Winter Conference is next week. We will be providing Chief 101 and new Chief 101 update classes, along with several more. IMAS update was given. Significant changes made to their website.
- 3. NCFFF Robert Templeton reported that six will be honored in May this year 4 for 2014 and 2 for prior years. We had two LODDs in the past quarter. Ed Brinson was reelected as President. We need to work harder at keeping LODD deaths down. He thanked everyone for their support.

Website is now up to date with important information.
